# **SERVICES AND PROGRAMS**

#### 1. Psychiatric Rehabilitation Program

CIHS PRP service is designed to offer therapeutic services to adolescents, minors and adults with persistent mental illness and maladaptive functioning. The program seeks to deliver services that are individualized, comprehensive and that addresses the psychosocial and rehabilitative needs of patients both on site and in the community. PRP services is a shortterm intervention used for children, youth and adults who may be at risk of being placed in a residential setting. The program provides a wide range of services that includes individual, group, family, community interventions, comprehensive mental health and rehabilitation services, vocational assistance, targeted case management and intensive integrative family programming. The goal is to assist caregivers with acquiring the needed skills to assist the person's served in their homes.

CIHS's jurisdiction is primarily Baltimore County, with service provision contacts in Baltimore County/City, Anne Arundel and Howard Counties. The program operates Mon-Saturday (crisis information available for Sunday) from 10:00 am to 6:00 pm.

### 2. Substance Abuse Program

CIHS's Substance Abuse Services are designed to support clients that are on a pathway to recovery from alcohol and other drug use challenges. We understand that seeking help for Alcohol and Drug addiction can be a difficult task. We offer holistic and highly individualized substance abuse treatment program for adolescents and adults. At CIHS, we believe in treating the whole person, not just the addiction. Clients receive treatment care from their own primary care physician and counselor – whom they know and trust.

CIHS's jurisdiction is primarily Baltimore County, with service provision contacts in Baltimore County/City, Anne Arundel and Howard Counties. The program operates Mon-Saturday (crisis information available for Sunday) from 9:00 am to 7:00 pm. Clinical hours are 9:00 am to 7:30 pm.

### Services offered include:

- Alcohol and drugs of abuse evaluation, medication management
- Coordination of twelve step self-help programs
- Case management services
- Randomized Urinalysis
- Specialized groups (including gender specific)

- Family, couple, and individual counseling sessions
- Individualized treatment planning & collaborative treatment approach
- DUI/Parole and Probation/Court Ordered Drug and Alcohol Counseling

#### Intensive Outpatient Program (IOP)

CIHS provides intensive outpatient substance use treatment for adults and adolescents. Individuals seeking treatment must meet American Society of Addiction Medicine criteria for IOP level of treatment. The program is a 12 to 24-week program where individuals receive a combination of group therapy, individual therapy, and in-home/community support with the goal of reducing or eliminating substance use. In all, individuals enrolled in the IOP program receive between 9-12 hours a week of treatment and support.

#### The program structure includes:

- Four (4) two (2) hour group sessions per week
- Individual counseling for SU
- Mental Health Counseling
- Transportation
- Housing (based upon availability)
- Community Integration (PRP)

### **Outpatient (OP)**

CIHS provides outpatient substance use treatment for adults and adolescents. Individuals seeking treatment must meet American Society of Addiction Medicine criteria for outpatient level of treatment. The program is a 12 to 24-week program where individuals receive a combination of group therapy, individual therapy, and in-home/community support with the goal of preventing relapse. The program structure includes:

- Three (3) one (2) hour group sessions per week.
- Individual counseling for SU
- Mental Health Counseling
- Transportation
- Housing (based upon availability)
- Community Integration (PRP)
